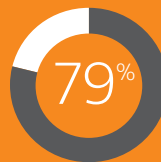

- Punctuation is properly paired
- Similar phrases and expressions are stated with consistency
- Numeration is correct at all levels in the document
- Open issues in the document have been addressed

Further, if your main document contains references to other documents, the referenced documents can also be analyzed.
